# Terms of Use

The Terms of Use apply to your use of justionite.com Site and the services offered through it. Your use of the Site indicates your acceptance of the Terms of Use, including the polices incorporated into them by reference. If you do not accept the Terms of Use, you must not use the Site or the services.

Site means the just tonite.com websites and applications owned or otherwise operated by just tonite.com.

justtonite.com may amend the Terms of Use from time-to-time by publishing changes on the website and applications.

The Terms of Use constitute the entire agreement between you and just tonite.com, and supersede any previous agreement or understanding.

## 1. Scope of our Services

#### A. Accommodation Reservation Facilitation

Through the Site, justtonite.com provides an online platform through which you can browse different types of lodging and temporary accommodation, limited to hotels and serviced apartments (collectively, the "Accommodation(s)") provided to us by our Supplier. You may book such Accommodations with a credit card, debit card or any other type payment instruments ("Payment Instrument"). By making a booking through the Site, you make an offer to book a reservation at the price listed for such reservation and such other terms and conditions stated on the Site. This shall become a binding contract formed in Malaysia pursuant to the Terms of Use when accepted by the Supplier and consequently justtonite.com. You will receive proof of the confirmed Accommodation booking via an e-mail confirmation, which means the booking has been confirmed and is completed, no further action is required by you.

When rendering our services, the information that we disclose about Accommodations is based on the information provided to us by our suppliers or providers, including but not necessarily limited to the suppliers or providers, their representatives, distributors, destination management companies (DMCs), channel managers, partners, etc. ("Supplier"). As such, the Suppliers or their representatives are given access to an extranet or other connectivity solution through which they are fully responsible for updating all rates, availability, description, pictures, booking conditions, accommodation policies and other information which is displayed on the Site. ## 3. Prices, Additional Charges, Taxes and Fees, justtonite.com exchange rates

Please note that, unless expressly indicated otherwise, all quoted prices on the Site are for room only reservations, run-of-house room type which will be determined and assigned by hotels upon guests arrival, for the pre-fixed check-in, check-out dates / time and maximum of 2 person per room, for a maximum of 2 rooms per hotel per day. Without prejudice to what is set out below, before you confirm a reservation, justtonite.com will display the total price payable, including relevant tax only.

#### A. Prices for Accommodations

We strive to fulfil your last-minute accommodation needs at a fixed price, for a night, the night for which the booking is made. We want your booking to be efficient and hassle free. These fixed prices are based on the respective Accommodation Categories and are different from the Suppliers' own website and other online platforms published prices. The price displayed is for room only, at run-of -house room type.

In the event you would like to extend your stay with the Supplier, you will express such needs directly to the Supplier, of which the price per night will go according to the Supplier's published price. Any prices for subsequent nights which are not transacted, booked through or reserved with justionite.com, will be the agreement between you and the Suppliers, where justionite.com will not be hold responsible.

Please take note the Accommodation Categories prices does not apply to Ancillary Services provided on the Site.

## **B.** Additional Charges by Accommodations

The reservation prices will include Sales and Service taxes. In addition to the reservation prices, you are subjected to other charge such as mandatory service fees and local taxes (for example, Tourism Tax, Heritage tax, Marine Conservation fees etc.) where applicable the Supplier will collect from you. For increased convenience, our payment processing service provider will also offer the option to have your Payment Instrument details securely stored on file. If you choose to store a credit or debit card with our payment processing service provider, you are complying to the provider's Terms of Use and Privacy Policy of its operations and data storage method.

Our payment processing service provider is a legal establishment and justtonite.com payment method over transactions is governed by our payment processing service provider. Justtonite.com believe that our service provider has been and will continue to put reasonable effort on audit and control of their operations over, including but not limited to, fraud detection and prevention mechanisms, to be in place. In certain cases, the payment processing service provider may require additional information or verifications to validate and confirm the booking, as explained in more detail on the Site.
